

TOWN OF SUN PRAIRIE
Regular Town Board Meeting
April 27, 2026

Call to Order: Supervisor D Yelk called the board meeting to order at 4:00 p.m. at the Town Hall, 5556 Twin Lane Road. Supervisor J Seltzner, Clerk R Wiedenbeck, Treasurer K Weisensel and Patrolman J Schuster were present. Guests: Vince Maly, David Finnerud from Payne & Dolan, Eric Maly, Collin Jacobson from Scott Construction, Matt McBurney, Andrew Sackett from Tri-County Paving, Meghan Mapes, and Adam Weisensel. Absent: Chairman L Updike.

Statement of Public Notice: Record in the minutes that the notice of this meeting was posted on the Town bulletin board located at the Town Hall and the Town's website on April 23, 2026.

Pledge of Allegiance: Patrolman J Schuster led the pledge.

Approve Minutes of Prior Meeting: There were no minutes to approve.

Presentation from the Public: Eric Maly came before the board to address the false allegations that were made against him, about running an illegal business. He provided a certification documentation that proved his business was a legal business.

Consider and Take Action: Open and award sealcoat & overlay bids. We received overlay bids from Payne & Dolan, Tri-County Paving, and Wolf Paving. Supervisor D Yelk opened the overlay bids. Patrolman J Schuster wanted to hold off on awarding the bid until later in the meeting.

We received a sealcoat bid from Scott Construction. Supervisor D Yelk opened the sealcoat bid. Patrolman J Schuster wanted to hold off on awarding the bid until later in the meeting.

Consider and Take Action: Approve the rezone request from Jim Muir, on Parcel #0811-181-9535-9, and Parcel #0811-181-9505-5, 5.8 acres, located at 5703 S. Bird St. Jim is changing the lot lines on these 2 lots. Currently the lot lines are North and South, the new change would make them go East and West. One lot will remain AG (Agriculture) and the other will be SFR (Single Family Residence). There are currently 2 driveways, he will be splitting the parcels between the 2 driveways. Each lot will have their own driveway. Supervisor J Seltzner motioned to approve the rezone as presented. Supervisor D Yelk seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Consider and Take Action: on a request from Vince & Betty Maly, on Parcel #0811-171-8580-0, 20.602 acres, currently zoned R-3A (Residential District), located at 2750 Bailey Rd. Vince & Betty would like to create a residential lot for a family member. Supervisor J Seltzner motioned to approve rezone for Vince & Betty Maly located at 2750 Bailey Rd to the 3 lots requested. Supervisor D Yelk seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Consider and Take Action: Approve the rezone request from Matt McBurney, on Parcel #811-192-8465-0, and Parcel #0811-192-8450-0, located at 3132 Bailey Rd. Matt is moving lot lines. Supervisor J Seltzner motioned to approve the new lot lines located at 3132 Bailey Rd. Supervisor D Yelk seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Road Report: Patrolman J Schuster wanted to verify the Town budget for Seal Coating and Overlay. The Town budgeted \$255,000.00 for 2026 Seal Coating and Overlay.

Supervisor J Seltzner motioned to approve \$254,150.00 up \$255,000 if needed. Supervisor D Yelk seconded the motion to accept the 2 lowest bids for both overlay and sealcoat. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Patrolman J Schuster also reported he has ordered the rest of the salt for 2026.

Consider and Take Action: Approve Resolution No. 2026-04-24, Town Board Resolution supporting a comprehensive and sustainable transportation funding solution. Supervisor J Seltzner motioned to approve the above Resolution No. 2026-04-24. Supervisor D Yelk seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Consider and Take Action: Approve Ordinance 2026-1, To Adopt a New Responsible Unit Recycling Ordinance and Repealing the Original Ordinance 94-1. Supervisor J Seltzner motioned to approve the New Recycling Ordinance 2026-1 and Repealing the Original Ordinance 94-01. Supervisor D Yelk seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Consider and Take Action: Cold Storage Building exterior makeover bid. Clerk, R Wiedenbeck will contact Wisconsin Towns Association to ask if more than one bid is required for this type of project. If the Town is able to award a contract without having to go for more than one bid, then Supervisor D Yelk motioned to accept the bid from Luke Freitag. Supervisor J Seltzner added to the motion, if no other bids come in the next 2 weeks, he would also approve the Luke Freitag bid. Supervisor J Seltzner seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Committee Updates

- a. **EMS & Fire:** Nothing to report.
- b. **Parks:** Patrolman J Schuster mowed the park. There are 2 trees that need to be cut down. The Park Committee will hire someone.
- c. **Town Zoning:** Had a meeting last Thursday night.
- d. **Planning Commission:** Discussion about the drain tile in Savannah Valley sub-division has come back up. Discussed, no action taken.

Audit and Pay Bills: Supervisor J Seltzner motioned to pay the bills for \$61,585.54, minus \$35, which comes out of the Park Fund. Supervisor D Yelk seconded. Aye votes: D Yelk, J Seltzner. Nay votes: None. Motion carries.

Old Business/New Business: Discuss landscaping plans for in front of the Town Hall. This was discussed and the area where the new well is, will be replaced with concrete. The area under the windows will remain landscaped with mulch.
